    - 1. Read all safety and operating instructions before operating IQube.
    - 2. Retain the safety and operating instructions for future reference.
    - 3. Follow all operating and use instructions.
    - 4. Do not attempt to service IQube yourself. Refer all non-routine servicing to Tactiles.
  - v. Seizure, Blackouts and Eyestrain
    - 1. A small percentage of people may be susceptible to blackouts or seizures (even if they have never had one before) when exposed to flashing lights or light patterns such as when playing games or watching video. If you have experienced seizures or blackouts or have a family history of such occurrences, you should consult a physician before playing video games or watching videos. Discontinue use of IQube and your smart device controller and consult a physician if you experience headaches, blackouts, seizures, convulsion, eye or muscle twitching, loss of awareness, involuntary movement, or disorientation. To reduce risk of headaches, blackouts, seizures, and eyestrain, avoid prolonged use, hold your smart device controller some distance from your eyes, use IQube in a well-lit room, and take frequent breaks.
  - vi. Repetitive Injury
    - 1. When you perform repetitive activities such as playing games on your smart device controller, you may experience occasional discomfort in your hands, arms, shoulders, neck, or other parts of your body. Avoid excessive play. It is recommended that parents monitor their children for appropriate play. Take frequent breaks and if you have discomfort during or after such use, stop use and see a physician.

- vii. **WARNING: Choking Hazards**
  - 1. IQube has small parts inside its enclosure, which may present a choking hazard to small children and pets. Keep IQube and its accessories away from small children.
- viii. **Keeping IQube Within Acceptable Temperatures**
  - 1. Operate and store IQube in a place where the temperature is between 0° and 40° C (32° to 104° F). Low or high-temperature conditions might temporarily shorten battery life or cause IQube to temporarily stop working properly. Avoid dramatic changes in temperature or humidity when using IQube, as condensation may form on or within IQube. Don't leave IQube in your car, because temperatures in parked cars can exceed this range. When you're using IQube or charging the battery, it is normal for IQube to get warm. The exterior of IQube functions as a cooling surface that transfers heat from inside the unit to the cooler air outside.
- d. **Use and Maintenance**
  - i. **WARNING: IQube is not suitable for use by children under 8 years of age.**
  - ii. **Never:**
    - 
    - 1. Abuse, throw, drop, puncture, violently kick or step on IQube. This can damage the kit and compromise its safe operation. •
    - 2. Operate IQube in dangerous, hazardous or public areas where use is not permitted (high voltage power lines, train stations, airports, trains). Check whether use of IQube is permitted before using it in public areas or public transport.
  - iii. **Always:**
    - 1. Periodically examine IQube for potential hazards such as cracked, damaged or otherwise broken parts. In the event of such damage, do not use IQube until it can be replaced or repaired.
  - iv. **Battery Warning**
    - 1. Lithium Polymer batteries are extremely hazardous and liable to cause serious injuries to persons or property. The user accepts liability for the use of a Lithium Polymer battery. As the manufacturer and the distributor cannot ensure the battery is used correctly (charging, discharging, storage, etc.), they cannot be held liable for damages caused to persons or property.
    - 2. In the event of battery leakage, avoid the liquid coming into contact with skin and eyes. In case of contact with the skin, wash copiously with soap and water. v. Charging

1. Examine the USB cord regularly for damage to the cord, plug, enclosure or other parts. The toy shall only be used with a laptop or personal computer USB port. If misused can cause electrical shock.
2. Never charge a leaky battery or one that has been damaged.
3. Do not charge the battery near inflammable materials or on an inflammable surface (carpet, wooden flooring, wooden furniture, etc.) or conducting surface. Do not leave IQube unattended during charging.
4. Never charge the device immediately after use while it is still hot. Let it cool down to room temperature.
5. Batteries are only to be charged under adult supervision.
6. Do not cover your product or its while the battery is charging. Recharge the battery at a temperature of between 0° and 40° C (32° to 104° F).

vi. Use and storage

1. Do not use IQube if its plastic has been broken and the Power Cube's battery's plastic cover has been cracked or compromised in any way.
2. Do not expose the IQube to excessive physical shock.
3. Do not expose IQube and its battery to heat or dispose of a fire.
4. Do not put the IQube in a microwave oven or in a pressurized container. Do not attempt to dismantle, pierce, distort or cut the battery and do not attempt to repair the battery. Do not place any heavy objects on IQube.
5. Do not clean the IQube with a solvent, denatured alcohol or other inflammable solvents. When cleaning, be sure to unplug the USB cord.
6. It is essential to avoid short circuits. Avoid direct contact with the electrolyte contained within the battery. The electrolyte and electrolysis vapors are harmful to health.
7. Do not subject IQube and its battery to large temperature variations. Do not place your IQube near a source of heat.
8. Disconnect the USB cable when you are not charging the battery.
